**Please Read Carefully and Sign**

I understand that a non-refundable registration fee of \$95 must accompany each camper's registration. I agree to make all future payments in advance of each session.

To sign up for one or two weeks only, payment in full is due at time of registration.

The camp tuition includes attendance from 8:00 am to 5:00 pm. Arrival before 8:00 am and/or departure after 5:00 pm, is considered extended care. Extended care can be arranged from 7:00 am - 8:00 am, and from 5:00 pm - 6:30 pm for an additional fee. The camp tuition includes (as applicable): transportation to and from field trips, swimming twice a week, out-of-camp trip fees, snacks, lunch and beverage, supplemental accident insurance. Registration includes two T-shirts and camp bag. It is each parent/guardian's responsibility to provide food for their child in the event of any dietary restrictions due to health, cultural, ethnic or any other reason.

Payment will be made every **MONDAY** morning in advance of service, or in the event of a Monday holiday, payment will be due on Tuesday. There is a \$5 per day late charge for payments made after the due day. I am responsible for payment for contracted week even if child is not in attendance. Payments can be made by cash, check, money order, VISA or Mastercard. There will be a \$30 fee for any returned check.

Overtime will be considered as drop-off before 8:00 am, or pick-up after 5:00 pm, unless pre-contracted and pre-paid. The overtime charge will be \$5 per 5-minute interval before 8:00 am, after 5:00 pm, or after 6:30 pm if pre-contracted. I agree to pay attorney's fees of 35% of the amount due plus any other costs and charges necessary for the collection of any amount not paid when due.

I agree that I will not solicit the current employees of My Second Home of Owings Mills for alternate employment. I agree to hold My Second Home of Owings Mills and its affiliates harmless in any situation that may occur should I retain the services of a My Second Home employee outside the My Second Home premises.

Field trips are planned on a daily basis. For any camper arriving after 9:00 am, parent or guardian will be responsible for providing transportation to field trip sites.

**TERMS AND CONDITIONS:**

A non-refundable registration fee is due with the application. To sign up for one or two weeks only, payment in full is due at time of registration. If you have to cancel for ANY reason and do so before May 1, 2007, you will receive a refund of payment, less the \$95 registration fee. If you cancel for ANY reason after May 1, 2007, then you forfeit your entire camp payment. If you switch to different weeks within the Adventure Camp program, there will be a \$50 administration fee. There will be a \$30 fee for all returned checks. My Second Home Adventure Camp will be closed July 4. In certain circumstances, it may be necessary for the Director to decide to discontinue a child's enrollment. Such a decision would be based on whether it is in the best interest of that child, the other children in the camp and/or the overall operation of the camp. Every effort will be made to correct a problematic situation before final decision is made.

Termination of enrollment may be the result of, but not necessarily limited to, the following:

- Non-payment of tuition or fees
- Center's inability to meet child's needs
- Disruptive or dangerous behavior
- Abuse of children, staff or property
- Continued violation of center's policies by student or parent

I will complete and return all required paperwork before my child attends camp. My child has permission, without restriction, to participate in all regular and special programming, including out-of-camp trips. My Second Home Adventure Camp and its designees have permission to use my child's photograph in press releases, ads, and news stories about camping and/or My Second Home Adventure Camp. The camp also has my permission to give my child's name, address and phone number to other members of his/her camp group to help friends keep in touch with each other outside of camp.
